1. The bidder must be a registered firm/company/LLP with valid GST registration and PAN.
2. The scope includes supply, installation, testing, commissioning, and handover of a complete CCTV surveillance system at the Incubation Centre, including all cameras, recording units (NVR), storage, cabling, accessories, software, and STQC certificate documentation required for smooth operation.
3. Bidders are encouraged to visit the site and assess the location prior to submission of quotation. No additional cost shall be payable for any item arising due to lack of site inspection.
4. Equipment offered must strictly comply with the technical specifications provided in the Quotation. Any deviation must be clearly mentioned in a deviation statement. Quotations without compliance details may be summarily rejected.
5. Only new, unused, and latest-manufactured equipment shall be supplied. Refurbished or obsolete models are not permitted. Preference may be given to equipment compliant with Government guidelines / BIS standards, wherever applicable.
6. The quotation shall be submitted on the bidder's letterhead, duly signed and stamped. Prices shall be quoted inclusive of all charges such as packing, forwarding, freight, insurance, installation, and testing. Prices once quoted shall not be revised during the validity period.
7. The quotation shall remain valid for a minimum period of 90 days from the last date of submission.
8. Applicable GST and other statutory taxes shall be clearly indicated. NITRRFIE shall not bear any tax or duty not explicitly mentioned in the quotation.
9. The complete supply and installation shall be completed within 15 days from the date of issue of Work Order.
10. Payment shall be released after successful installation, testing, and commissioning, and submission of a proper tax invoice. Payment shall be subject to certification by the authorized officer of the NITRRFIE.
11. No advance payment shall be made, unless approved by the competent authority.
12. The bidder shall provide a comprehensive on-site warranty of minimum 01 years from the date of commissioning. Warranty shall cover all parts, labour, and replacement without any additional cost.
13. The bidder shall provide details of post-warranty Annual Maintenance Contract (AMC), including scope, response time, and charges. Preference may be given to bidders with local service support.
14. The bidder shall provide: Basic operational training to designated staff, User manuals and technical documentation, System layout and IP configuration details. All at no additional cost.
15. The bidder shall maintain strict confidentiality regarding surveillance data, system architecture, and premises layout. No data shall be accessed, copied, or disclosed without written permission of the NITRRFIE.
16. NITRRFIE reserves the right to accept or reject any or all quotations, partially or wholly, without assigning any reason, as per applicable procurement norms.
17. The order may be terminated by the NITRRFIE in case of: Non-performance or unsatisfactory performance, Supply of substandard or non-compliant equipment, Breach of terms and conditions, Without any financial liability.
18. NITRRFIE shall have the right to inspect relevant documents related to the execution of the order.
